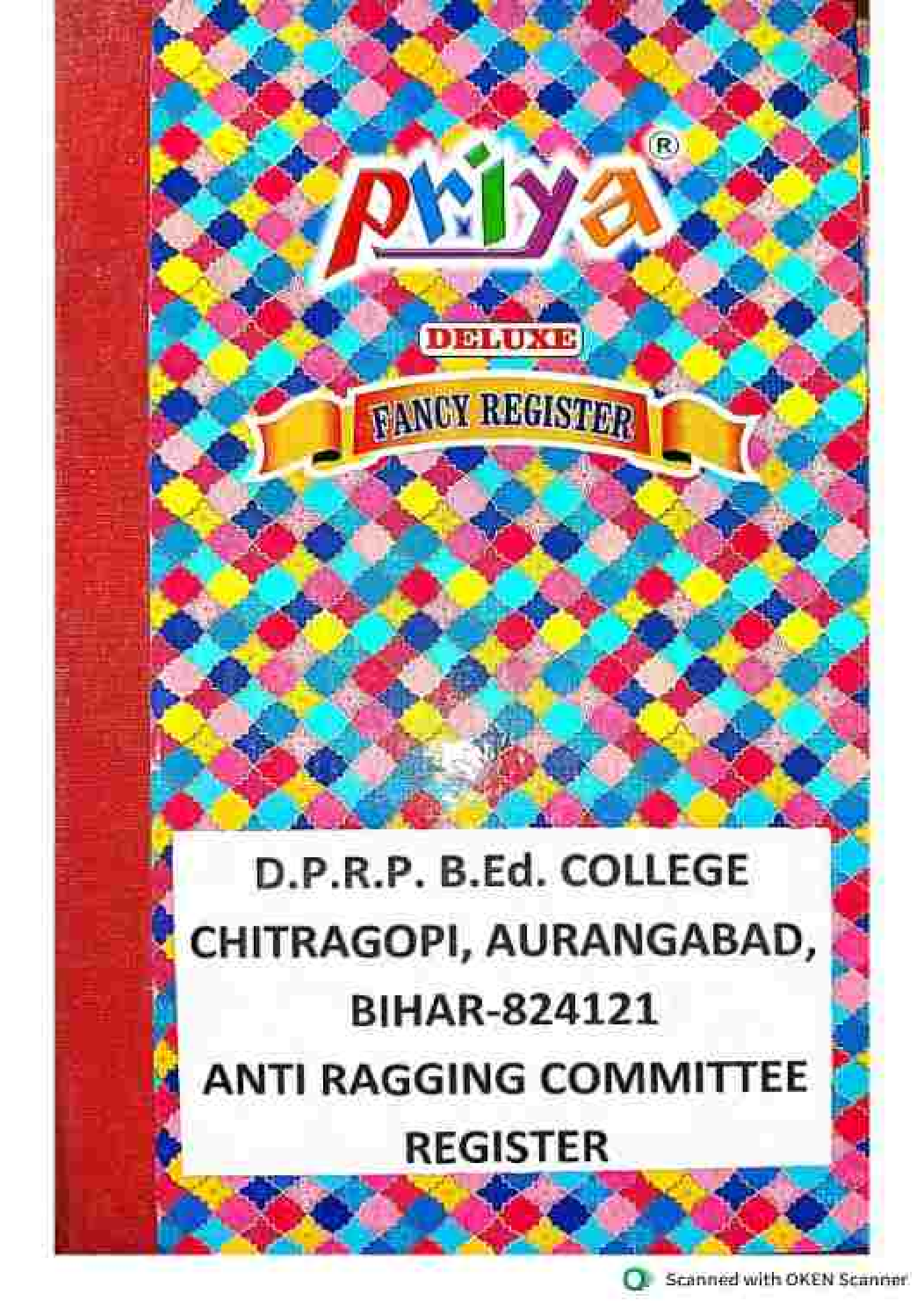

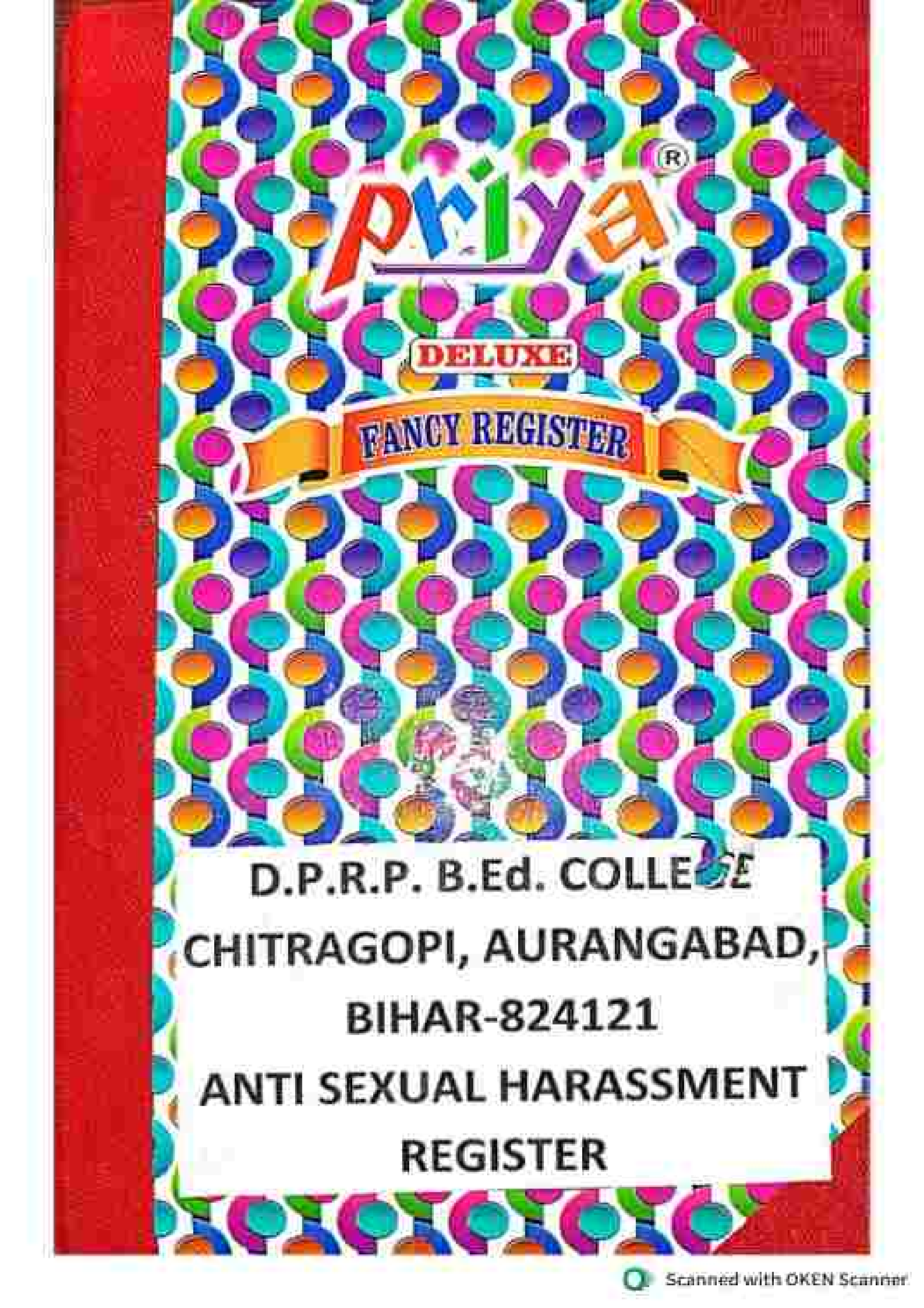

With regard to the Supreme Court judgement in August 1997 (Vishaka & others v. the State of Rajasthan & others) stated that every instance of sexual harassment is a violation of "Fundamental Rights" under Article 14, 15 and 21 of the Constitution of India and violation of "Right of Freedom" under Article 13(1)(8) guideline to provide for the effective enforcement of the basic human right of gender equality and guarantee against sexual harassment at work places. Hence following the guidelines, The University Grants Commission (UGC) circular since 1998 to all the universities advising them to establish a permanent cell and a committee to combat sexual harassment. Another Supreme Court judgement in January 1999 (Apparal export promotion council vs. chopra) has stated that sexual harassment is a violation of the fundamental right to gender equality and the right to life and liberty, thus it should be eliminated completely without any compromise.

Based on these universities made it mandatory to form sexual Harassment Cell. DRRP BED college decided to form an Anti Sexual Harassment.

to form an "Anti Sexual Harassment Committee" so that students, teachers and non-teaching staff of female gender can work together in environment free of violence harassment, exploitation and intimidation. Following faculty members of various departments and girl students are part of the committee and they have taken charge and assigned the role and responsibilities of Anti Sexual Harassment Committee with immediate effect.
